THIS CONCEPT OF COMMUNITY EMPOWERMENT HAS PROVEN TO BE HIGHLY EFFECTIVE, LEADING TO SIGNIFICANT ADVANCEMENTS IN GLOBAL REEF CONSERVATION AND COMMUNITY DEVELOPMENT.
